DIALOGUES: THE CHALLENGES OF ILLEGAL MINING IN THE AMAZON

Summary: The advance of illegal mining into the forest, indigenous territories and environmentally protected areas is a priority issue in Brazil. In the Amazon, illegal small scale gold mining is already taking place on an industrial scale and has left a trail of destruction of biodiversity and violation of the lives and rights of indigenous populations. After control measures were adopted in 2023, the Brazilian gold market went into shock, with significant falls in the production and export of the metal. Important steps to control the gold trade have been taken, with significant effects on the market. Others, however, are still needed to complete the journey to the effective transformation of the sector. To this end, combating illegal gold mining must be a priority, because it causes severe environmental and social impacts, as well as establishing unfair competition in the market. It is also essential to improve the rules governing small scale gold mining operations, so that they adhere to reality. The Amazon and New Economies International Conference Dialogues aim to discuss the issue of illegal small-scale gold mining, its impacts, the related regulatory and legal issues, as well as pointing out the necessary command and control measures and strategies to regulate the activity.

DIALOGUES: THE CHALLENGES OF INVESTMENTS IN INFRASTRUCTURE AND LOGISTICS IN THE AMAZON AND THE SUSTAINABILITY OF THE TERRITORY.

Summary: The Amazon is the main frontier for major infrastructure investment projects in Brazil over the next few years. Among the initiatives planned are a set of logistics integration projects between land and water transportation, which aim to connect the production of the North and Central-West regions with the ports of the Amazon basin. The installation of infrastructure services to provide local water, sanitation, health, mobility and energy has an immense capacity to attract capital to the region's economy and generate benefits for the population. However, in order to produce the desired results, it is essential that the implementation of infrastructure in the Amazon takes into account the heterogeneity and complexity of the region, promoting development based on the social, economic and environmental peculiarities of each territory. Discussing the relationship between infrastructure X planning X sustainability is the aim of this Dialogue, as well as pointing out possible ways forward.
