Summary: "Brazil's potential for critical and strategic minerals has emerged as a central axis for sustainable development and global mineral security, in the face of growing demands for resources that are essential for energy transition and technological innovation. This panel proposes a strategic reflection on the country's geological opportunities - lithium, niobium, copper, nickel, uranium and rare earths, for example - combined with the socio-environmental and regulatory challenges surrounding their exploitation. The panel proposes a discussion on the need to integrate agendas such as ESG, efficient governance and innovation in the value chain, transforming natural wealth into products with a high economic impact. Simultaneously, public policies and international cooperation capable of positioning Brazil as a global player must be addressed, without neglecting dialogues with communities and ecological balance. Based on national cases and guidelines such as the National Mining Plan 2050, the debate aims to generate practical recommendations for overcoming bottlenecks and consolidating mining in line with the principles of sustainability, competitiveness and social inclusion. "

Summary: The number of leaves of absence due to mental disorders in Brazil has been increasing annually, prompting discussions across various sectors about the influence of workplace dynamics on this scenario. According to data released by the Ministry of Social Security, the number of benefits granted by the INSS related to mental health issues has risen by 38% in recent years. Additionally, the Occupational Health and Safety Observatory reported in 2021 that mental disorders ranked as the third leading cause of occupational leave in the country. According to the World Health Organization (WHO), mental health can be defined as a state of well-being in which individuals realize their own abilities, can cope with the normal stresses of life, work productively, and contribute to their community. Mental health is influenced not only by individual factors but also by social, environmental, and economic aspects. Work is a key part of the social context, providing individuals with a sense of purpose, achievement, motivation, and belonging. Thus, mental health in the workplace can be understood as the psychological well-being of employees in a professional context, including aspects such as resilience, job satisfaction, and fulfillment. This concept goes beyond the absence of mental illness, addressing the management of psychosocial risks, burnout prevention, and the promotion of a healthy organizational culture, mainly grounded in principles and concepts of Psychological Safety. Therefore, the work environment can often be a determining factor in mental illness—but it can also be part of the solution when there is a commitment to preventing, identifying, and addressing psychosocial risk factors in the workplace. Research and evidence show that mentally healthy workers tend to be more productive, engaged, and creative. By managing psychosocial risks, organizations reduce absenteeism, lower turnover rates, minimize labor and social security issues, and significantly enhance their reputation—making them more attractive as employers. However, the success of any initiative to mitigate psychosocial risks will depend on a paradigm shift: recognizing that mental health is not a secondary issue but a fundamental component of business sustainability. This requires the engagement of top management, the involvement of multidisciplinary teams, and the active participation of the workers themselves. This panel proposes a technical and practical reflection on how taking care of the mental health of all workers in an organization—including those in leadership and management positions—contributes to building safer, healthier, and more productive workplaces. Based on three thematic pillars—psychological safety, mental health, and support in cases of addiction, alcohol, and other dependencies—real-world experiences will be presented to demonstrate how caring for people positively impacts organizational performance across all dimensions of total quality.

## Panel 18 - Economic Geology and Mineral Research

Summary: We are seeing a trend towards increased investment in the development of mineral research, expansion and new projects in the sector. The main reasons driving this increase are based on global environmental and geopolitical issues, which are at the core of the debates and guidelines that countries are trying to establish for the future, in the short, medium and long term. The geopolitical aspects involving the main producers, and the holders of these resources and of knowledge and technologies, have motivated the race for investments and strategic policies. In this panel we will discuss Brazilian economic geology with a focus on the main mineral deposits and provinces with the potential to supply the growing demand for elements such as lithium, nickel, cobalt, rare earths, copper and graphite.
